Hotiì ts'eeda Student Bursary - 2020

Covid-19 has presented a number of barriers to students in the NWT. Hotil ts'eeda is offering bursaries to students who can demonstrate how they have been impacted by the pandemic in ways that have become barriers to continuing their post-secondary education, and how a bursary would use these funds to further their education.

Hotiì ts'eeda is receiving applications for bursaries valued at \$5000.00 (for 2 semesters) for students without dependants, and additional supplement for students with dependants. Bursaries are intended to support students undertaking studies that further Hotiì ts'eeda's mandate of fostering research and training in health and wellness.

At this time, up to \$100,000.00 in bursaries will be awarded.

Bursary Eligibility:

- If you are First Nation, Inuvialuit, or Métis proof of membership is required.
- Must be an NWT resident.
- Must be able to provide proof of full-time enrollment at a designated post-secondary educational institution or program.
- Must demonstrate negative financial impacts resulting from the Covid-19 pandemic precautions.
- Must be in a program that leads to a licence, certificate, diploma, or degree that fulfills Hotil ts'eeda's mandate of fostering research or training in health and wellness.

To apply:

- Fill out the attached form.
- Provide a Letter of Intent (up to 1 page) describing the direct negative financial impacts of the Covid-19 pandemic precautions on your financial situation, including barriers you face as a result of the Covid-19 pandemic precautions in place since the pandemic was declared and during the upcoming school year, and how you intend to use the funds to further your education. The letter must also indicate all other confirmed sources of funds you will rely on to undertake your studies during the 2020-21 school year.
- Provide proof of NWT residency (government ID or utility or phone bill in your name, confirming your place of residence in the NWT).
- Provide proof you are a member or beneficiary of a NWT First Nation, Métis Local, land claim and that you are normally resident in the NWT.
- Provide proof of enrollment from your institution of study.





Priority will be given to NWT Indigenous residents who have demonstrated a financial need and are in a health and wellness related program.

 - 6. Hotiì ts'eeda will review applications and make decisions about awards. The application review process is internal and confidential to Hotiì ts'eeda. The award process and decisions are not subject to review or appeal.
 - Not all applications for awards will be successful. Hotil ts'eeda expects to receive far more applications than awards available. Unsuccessful applications will be deleted or destroyed and not retained by Hotil ts'eeda.

3. I understand that I may have to immediately return any Hotiì ts'eeda Bursary if there are changes to any of the information provided.
