2025 AMENDMENTS TO THE TLİCHQ ASSEMBLY MEMBERS AND CHIEFS TRANSITION ALLOWANCE LAW

TITLE

1. This law shall be cited as the *2025 Amendments to the Tłıchq Assembly Members and Chiefs Transition Allowance Law*.

DEFINITION

2. In this law definitions shall have the same meaning as the *Tłıchq Assembly Members and Chiefs Transition Allowance Law*.

AMENDMENT

3. Section 3 of the *Tłıchq Assembly Members and Chiefs Transition Allowance Law* is repealed and replaced by the following:

“Annual Salary” means:

- (a) For a member of the Assembly- the annual remuneration referred to in Section 2 of Schedule C of the *Tłıchq Assembly and Chiefs Executive Council Law*.
- (b) For the Chief of Behchokq - the annual remuneration referred to in Section 3 of Schedule C of the *Tłıchq Assembly and Chiefs Executive Council Law*.
- (c) For the Chief of Whatì - the annual remuneration referred to in Section 4 of Schedule C of the *Tłıchq Assembly and Chiefs Executive Council Law*.
- (d) For the Chief of Gamèti – the annual remuneration referred to in section 5 of Schedule C of the *Tłıchq Assembly and Chiefs Executive Council Law*.
- (e) For the Chief of Wekweètì – the annual remuneration referred to in section 6 of Schedule C of the *Tłıchq Assembly and Chiefs Executive Council Law*.
- (f) For the Grand Chief - the annual remuneration referred to in Section 7 of Schedule C to the *Tłıchq Assembly and Chiefs Executive Council Law*.

4. Section 4 of the *Tł̓chq Assembly Members and Chiefs Transition Allowance Law* is repealed and replaced by the following:

(a) A member of the Assembly or a Chief, including the Grand Chief, shall be paid a transition allowance equal to one-twelfth of their Annual Salary for each consecutive year of service, up to a maximum of their Annual Salary, if he or she:

(i) resigns his or her seat as a member of the Assembly, as a Chief or Grand Chief; or

(ii) has completed his or her term as a member of the Assembly, as a Chief or as the Grand Chief.

(b) The maximum transition allowance as described in 4(a) above does not apply to a member of the Assembly or a Chief, including the Grand Chief, of the 5th Tł̓chq Assembly.

COMING INTO FORCE

5. This law shall come into force on the date the Grand Chief signs this law.
