INSTRUCTIONS: You must answer all questions in detail on this application form unless otherwise indicated. Incomplete application will delay approval process. Submit completed application to the Behchoko Presence Office.

- If your application is approved, you will receive a callback from our staff and a PO number will be issued to your name at our local gas station for a total of \$350.00
- If you haven't received a call about your application, this means your application is pending and require more information for approval.

APPLICATION PROCESS: Applications will ONLY be received between Monday & Thursday to be processed within the same week. Applications received after Thursday will be processed the following week.

- **Application intake:** Monday, Tuesday, Wednesday & Thursday
- **Purchase Order release:** Friday morning
- **Approval calls:** Friday afternoon
