De Beers Group has an exciting opportunity for four Environmental Summer Students to provide support to environmental program activities during the busy summer field season. The ideal candidates will be enthusiastic and motivated post-secondary students from our Impact Benefit Agreement (IBA) Communities. The expected length of employment will be four months spanning from April 25th to August 29th, 2019. The start and end date can be flexible to accommodate school schedules. The ideal candidate is one who enjoys travel, is committed to safe working practices and strives for zero harm.

Primary Responsibilities:

- Collecting, monitoring, entering data and analysis of required environmental data as required under our operating permits;
- Completing field work in a remote environment, which may include heavy lifting;
- Maintaining appropriate records and databases;
- Keeping appropriate notes and drafting memos and letters as required;
- Assisting in the coordination of waste management and spill prevention programs;
- Providing logistical support including crew movements by truck, sample delivery to logistical personnel, staging of equipment and other tasks as assigned;
- Participation of in technical fieldwork assisting Technicians and Scientists in the collection of environmental data;
- Drafting daily safe work plans which will identify the risks and associated controls pertaining to the tasks to be completed;
- Demonstrating a strong commitment to the company safety, health and environmental culture;
- Participating in all training provided at the work site;
- Adhering to policies of the De Beers Group; and
- Supporting the Environment Department and consultants in other related tasks as required.

Requirements:

- Preference given to members of the Deninu Kué, Lutsel K'e Dene First Nation, North Slave Métis Alliance, Northwest Territory Métis Nation, Tlicho Government, or Yellowknives Dene First Nation and residents of the NWT;
- Proof of enrollment in post-secondary schooling in the environmental sciences;
- Knowledge of applicable regulations, regulatory processes and technical aspects of diamond mining;
- Physically fit and able to work 12 hour days in potentially unfavourable weather conditions;
- Ability to travel to remote sites by helicopter and boat;
- Proven commitment to Safety, Health and Environment Standards;
- Experience in the mining industry with operations at a remote site would be an asset;
- Environmental sampling, monitoring and reporting experience would be an asset;
- The ability to operate and maintain equipment (snowmobiles, boats and quads) would be an asset; and
- Possession of valid Pleasure Craft Operator Certificate (PCOC) would be an asset.
