a) RCMP Monthly Presentation Report

Cpl. James Mceachren gave a verbal report and informed Chief and Council that this will be the last Council Meeting that Cpl. Fred LeClerc will attend as he will be transferring to Yellowknife in the next few weeks. Chief and Council thank Fred for his services in the community. Cpl. Fred also thank Chief and Council for welcoming him in the community and stated that he and his family really enjoyed there stay.

b) Phase Two Renovation - Curling Rink Area

Tammy Steinwand, Director with the Cultural & Lands Department with the Tłįchǫ Government presented Chief and Council with a verbal report on relocating there Cultural and Lands Department to the Curling Rink Area as her department is set to expand in employees in the new year and their current working location does not meet the departments needs.

Kate Fane and Simon Taylor from Taylor Associates also presented Chief and Council with a blueprint on what work will be completed and the outcome of how the offices will look when construction is completed.
