

THE 2023 LAW TO AMEND THE TŁIČHQ LAND USE PLAN LAW

Title

1. This law shall be cited as the *The 2023 Law to Amend the Tłıchq Land Use Plan Law*

Definitions

2. In this Law,
“Tłıchq Assembly” has the same meaning as in the Tłıchq Constitution.
“Tłıchq Government” means the Tłıchq Government and its institutions as defined in the Tłıchq Constitution.
“Tłıchq lands” has the same meaning as in the Tłıchq Agreement.
“Tłıchq First Nation” has the same meaning as in the Tłıchq Agreement.

Preamble

3. WHEREAS on the effective date of the Tłıchq Agreement, Tłıchq Government, on behalf of the Tłıchq First Nation, was vested with title to lands totalling approximately 39,000 square kilometres, including the mines and minerals that may be found to exist within, upon or under such lands (Tłıcho lands);

AND WHEREAS Tłıcho Government has the power to enact laws in relation to the use, management, administration and protection of the Tłıcho lands and the renewable and non-renewable resources thereon;

AND WHEREAS Tłıchq Government enacted the Tłıchq Land Use Plan effective April 25, 2013;

AND WHEREAS pursuant to 7.9 of the 2013 enacted Tłıchq Land Use Plan, a “Plan Review” was initiated by the Department of Culture and Lands Protection (DCLP) that re-evaluated the entire Tłıchq Land Use Plan. Recommendations from a special review committee called the “LUP Review Committee” (LUPRC) provided direction to DCLP staff. A series of comprehensive revisions to the Tłıchq Land Use Plan were developed through October, 2023;

This Law was signed by Grand Chief Jackson Lafferty on October 12, 2023.

AND WHEREAS Tłıchq Government, with the advice and guidance of the LUPRC and DCLP, and after community meetings and other consultations and engagements, have completed a series of proposed revisions to the Tłıchq Land Use Plan;

AND WHEREAS the proposed revisions are contained in the Tłıcho Land Use Plan that is attached as Schedule A to this law.

Tłıchq Land Use Plan

4. The Tłıcho Land Use Plan Law is hereby amended by repealing Schedule A and replacing it with the Schedule A attached to this law.
5. The Tłıchq Land Use Plan attached as Schedule A to this law is hereby in effect.

Coming into Force

6. This law shall come into force on October 13, 2023
