TŁĮCHQ ASSEMBLY AND CHIEF'S EXECUTIVE COUNCIL SCHEDULE B AMENDMENT LAW 2009

Title

1. This law may be cited as the Thcho Assembly and Chiefs Executive Council Schedule B Amendment Law 2009.

Definition

2. In this law, the definition shall have the same meaning as the *Thcho Assembly and Chiefs Executive Council Law*.

Amendment

- 3. Schedule A of the *Tłycho Assembly and Chiefs Executive Council Law Schedule B Amendment Law 2005* is amended in accordance with Schedule A of this Law.
- 4. Each of the Chiefs and the Grand Chief shall not benefit from any compensation, including honoraria or other fees, for attendance at meetings or sittings on Boards or other institutions as a Thcho Government representative.
- 5. Should some form of compensation be mandatory from a role identified in section 4 the compensation shall be turned over to the Thcho Government and be treated as Thcho Government revenues.

Retroactive effect

6. Section 3 of this Law shall have retroactive effect until August 4, 2009.

Coming into force

7. This Law shall come into force on the date when the Grand Chief signs this Law.

SCHEDULE A

- 1. The remuneration for the Members of the Assembly, other than the Grand Chief and the Chiefs shall be \$500.00 per day for attending all meetings, conferences and workshops including sittings of the Assembly and shall be adjusted according to the Consumer Price Index on an annual basis.
- 2. In addition to the amount set in section 1 of this Schedule, the remuneration for Members of the Assembly, other than the Grand Chief and the Chiefs shall be a base of \$12,000 per annum and shall be adjusted according to the Consumer Price Index on an annual basis as of August 4, 2005.
- 3. The remuneration for each Chief while a member of the Assembly shall be \$110,000 per annum and shall be adjusted according to the Consumer Price Index on an annual basis as of August 4, 2005.
- 4. The remuneration for the Grand Chief while a member of the Assembly shall be \$140,000 per annum and shall be adjusted according to the Consumer Price Index on an annual basis as of August 4, 2005.
