## TŁĮCHQ ASSEMBLY AND CHIEF'S EXECUTIVE COUNCIL -SCHEDULE B AMENDMENT AND ADDITION OF SCHEDULE C LAW 2017

### Title

1. This law may be cited as the *Tłącho Assembly and Chiefs Executive Council - Schedule B Amendment and Addition of Schedule C Law* 2017.

## **Definition**

2. In this law, the definitions shall have the same meaning as the *Tł*µcho Assembly and Chiefs Executive Council Law.

#### Amendment

3. Schedule A of the *Tłącho Assembly and Chiefs Executive Council Law Schedule B Amendment Law 2009* is repealed and replaced with Schedule C as attached to this law.

#### Retroactive effect

4. Section 3 of this Law shall come into effect on August 1, 2017.

# Coming into force

5. This Law shall come into force on the date when the Grand Chief signs this Law.

#### SCHEDULE C

- 1. The remuneration for the Members of the Thcho Assembly, other than the Grand Chief and the Chiefs shall be \$550.00 per day for attending all meetings, conferences and workshops including sessions of the Thcho Assembly and shall be adjusted according to the Consumer Price Index on an annual basis.
- 2. In addition to the amount set in section 1 of this Schedule, the remuneration for Members of the Thcho Assembly, other than the Grand Chief and the Chiefs shall be a base of \$26,033 per annum and shall be adjusted according to the Consumer Price Index on an annual basis.
- 3. The remuneration for the Chief of Behchokò while a member of the Thcho Assembly and Chiefs Executive Council shall be \$166,556 per annum and shall be adjusted according to the Consumer Price Index on an annual basis.
- 4. The remuneration for the Chief of Whatì while a member of the Thcho Assembly and Chiefs Executive Council shall be \$152,560 per annum and shall be adjusted according to the Consumer Price Index on an annual basis.
- 5. The remuneration for the Chief of Gamètì while a member of the Thcho Assembly and Chiefs Executive Council shall be \$145,561 per annum and shall be adjusted according to the Consumer Price Index on an annual basis.
- 6. The remuneration for the Chief of Wekweeti while a member of the Thcho Assembly and Chiefs Executive Council shall be \$139,963 per annum and shall be adjusted according to the Consumer Price Index on an annual basis.
- 7. The remuneration for the Grand Chief while a member of the Thcho Assembly and Chiefs Executive Council shall be \$202,556 per annum and shall be adjusted according to the Consumer Price Index on an annual basis.
